One Thousand Nine Hundred and fifty-five
Between ADELINE JORDAN and STANLEY JORDAN, her husband, residing

in the Township of Brick County of Ocean
and State of New Jersey parties of the first part;

And SILVER BEACH ASSOCIATION, a corporation of the State of New
Jersey, having its principal office

in the Township of Dover County of Ocean
and State of New Jersey part of the second part;

Witnesseth, That the said part of the first part, for and in consideration of
ONE (\$1.) DOLLAR
and other good and valuable consideration
lawful money of the United States of America, to them in hand paid by the said part y of the
second part, at or before the executing and delivery of these presents, the receipt whereof is hereby
acknowledged: have remised, released, and forever Quit-Claimed, and by these presents do
remit, release, and forever Quit-Claim unto the said party of the second part, and to its
successors and assigns forever.

And their estate, right, title, interest, property, claim and demand
whatsoever of the parties of the first part in and to the conditions,
limitations, rights of reverter and reservations contained in a
certain deed dated April 7, 1945 made between Adeline Jordan and
Stanley Jordan, her husband, as Grantors, to Silver Beach
Association as Grantee, which said deed was recorded in the Ocean
County Clerk's office on August 22, 1950 in Book 1372 of Deeds
at page 160 to the end that the same shall be terminated, cancelled
and annulled.

ALSO ALL their estate, right, title, interest, property, claim and
demand whatsoever of the parties of the first part in and to
the conditions, limitations and reservations contained in a
certain deed dated July 19, 1950 made between Adeline Jordan
and Stanley Jordan, her husband, as Grantors, and Silver Beach
Association, as Grantee, which said deed was recorded in the Ocean
County Clerk's office on August 22, 1950 in Book 1372 of Deeds
at page 158 to the end that the same shall be terminated,
cancelled and annulled.

Together with all and singular the tenements, hereditaments and appurtenances therunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

And also, all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said parties of the first part, of, in or to the above described premises, and every part and parcel thereof, with the appurtenances. To have and to hold, all and singular, the above mentioned and described premises, together with the appurtenances, unto the said party of the second part, its successors and assigns, to its own proper use, benefit and behoof forever.

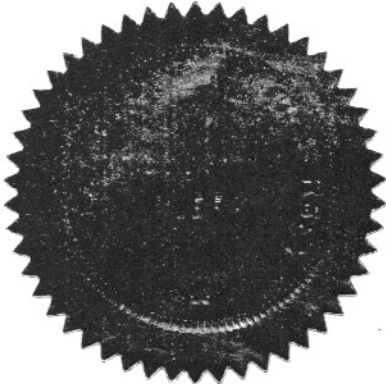
